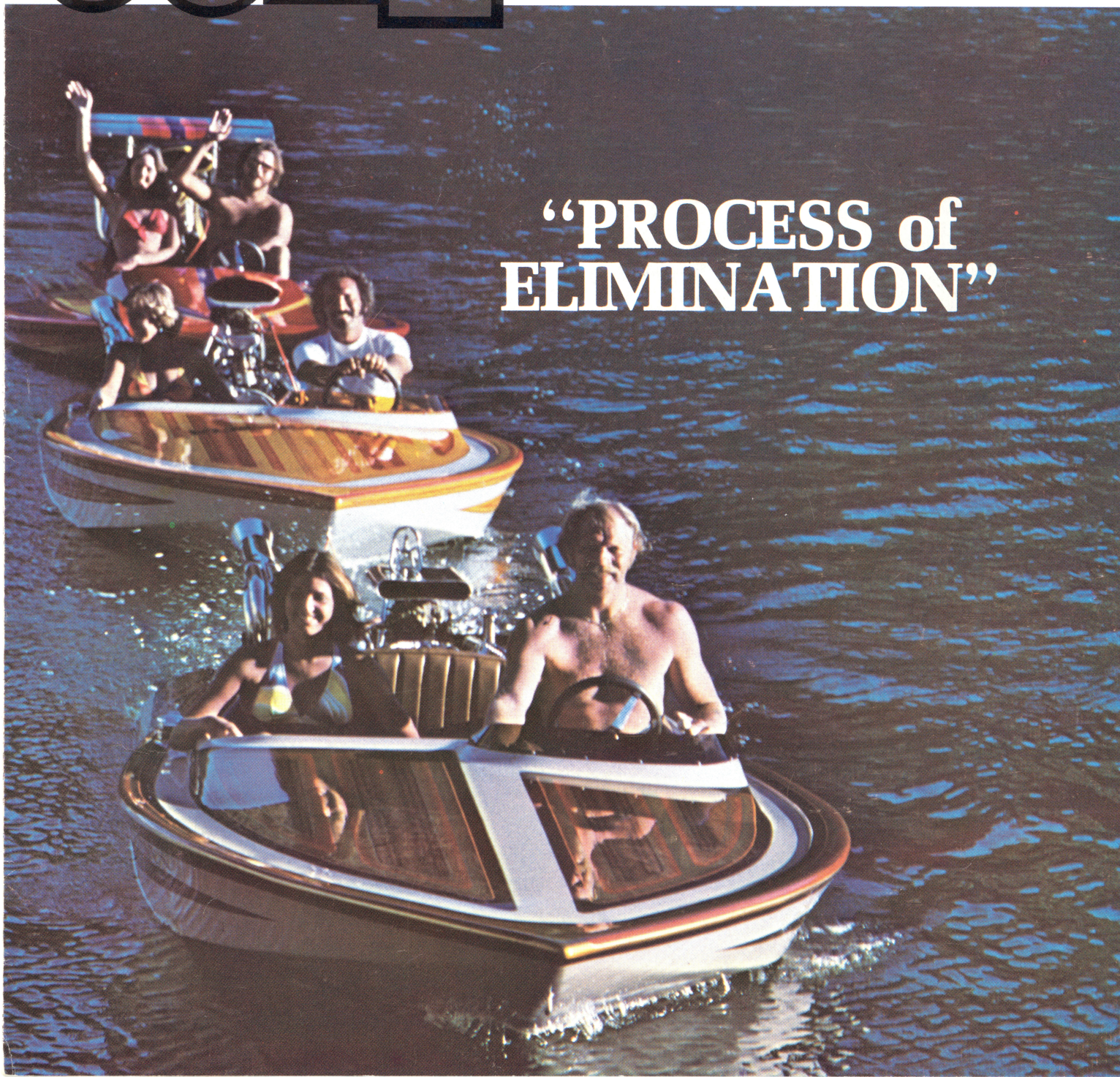

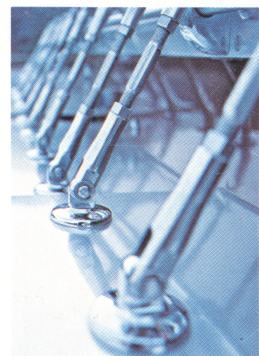
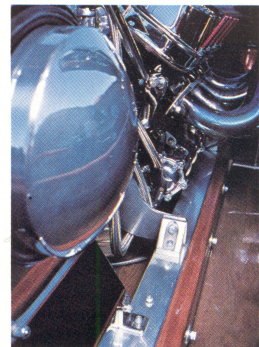

## LIMITED WARRANTY

For a period of one (1) year from the date of delivery to the original purchaser, Cole Boats warrants each boat covered by this warranty to be free from defects caused by faulty workmanship or materials. In the event that a boat is used for commercial purposes, the warranty shall be for a period of ninety (90) days from the date of the original purchase.

During this period the warranty repairs will be made without charge by Cole at its plant at the address set forth hereinbelow. Transportation costs for the return of an allegedly defective boat for repairs are the responsibility of the owner. The liability of Cole shall be limited to repair or replacement under this warranty of any boat which, upon examination at Cole's plant, is found to be defective during the warranty period.

*This warranty does not apply to:*

(1) Any failure resulting from lack of maintenance, normal wear and tear, or climatic conditions; (2) Engines, engine parts, jet drive, V-drive, controls, gauges, batteries or other equipment and accessories not manufactured by Cole (any warranty furnished by such manufacturer, if possible, will be passed on to the original purchaser); (3) Machinery, equipment, and accessories not installed by Cole; (4) Windshields and/or splash shields breakage; (5) Gelcoat finish and/or trim paint;

(6) Upholstery damage such as that caused by puncturing, storage, solvents or cleansers; (7) Any misuse, negligence or accidents; (8) Any boat or part thereof which has at any time during and after use, been used in any contest or competitive trial of acceleration, speed, time, distance, skill, or endurance, or any form of racing whatsoever, whether organized or unorganized; (9) Damage resulting from impact, grounding, or upset; (10) Damage caused by loose gear or equipment aboard; (11) Any boat which has been overpowered, or overloaded (in excess of its capacity as specified on the Capacity Plate on each Cole boat.)

**This warranty is the only express warranty applicable to products manufactured by Cole Boats and is in lieu of any other express warranties. Any implied warranty is limited in duration to a period of one (1) year from the date of original purchase and runs only in favor of an original consumer purchaser. Cole neither assumes nor authorizes any other person to assume for it any other liability in connection with such products. This warranty is intended to comply with federal statutes and regulations, and the laws of the state of California. This warranty remedy shall be exclusive and in no event shall Cole be liable for incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.**
